This attempt at rationality in the current and indeed eternal Mid-East conflict(s) has engendered a title that speaks to its nature. No matter the view of the conundrum, it appears and is as well impossible to untie the issues and unlock the cords that bind. This a dance that benefits others and certainly not the participants, the music played is composed by nefarious elite elements without care to the wear and tear on the dancers. The dancers are consumables as the music blares louder and louder, a cacophonous mastering of righteous indignation and felonious proposals all to sustain the dance, better called a march.

The concept of 'this land is my land, this land is your land....' is spurious in the extreme; power and conflict has determined 'ownership and occupation' temporally. Any assertion to the contrary must of necessity ignore proceeding occupations and conquests. In the instance of the Middle-East conflict(s) who is to determine the originals. acknowledging that at the earliest conceivable precivilizational time-origins, people or peoples owned not the land. Powerful tribes eventually assembled and 'claimed' the land only to be dispossessed by others ad infinitum. Of course one can refer back to historical writings/histories which are unbiased and accurate beyond question(?). The point I like to make is that appealing to presumed historical data as reference is a fools errand. Following on the 'logic' of the foregoing, an approach to an 'acceptable' solution must avoid appealing to past conceptions - atrocities, thefts, entitlements - God directed etc. Unless and until all parities can disabuse themselves of preconceived 'notions' this situation will live in infamy. The point is that there is no solution that can possibly be achieved without addressing preconceived grievances as was done following the fall of Apartheid in South Africa and to some extent with the Nuremberg Trials following the second world war. Therefore it is an exercise in futility for others to attempt to conceive, develop and implement a 'plan' to resolve the conflict. At all times and all places, 'Power" is the overriding motivation of certain individuals and associations in and of states. Concepts of morality, equity, fairness do

not play in the milieu that exists and has existed for millennium. Accepting this premise can one possibly align benign forces that acknowledges this reality and develop a power-centric formula that exposes the weaknesses in the conflicting parties positions and leverages them to a mutually acceptable compromise? Currently opposing and supporting agencies are reaping financial and geopolitical advantage from maintaining the status quo and have no interest in a resolution.

Nothing in the previous implies support or rejection of either sides actions in the Israeli/Gaza Conflict; there is no right on either side, both complicitous in inhumane atrocities. As well judgements regarding outcomes in the Ukraine Conflict are withheld although much is exposed in both of elite power structure manipulation.

In light of the above it is likely the best approach for citizens of the world is to avoid emotional attachment to a 'solution' and as well to an economic and political outcome; to all extent possible withhold practical and emotional support from The Powers. To the extent that voting has relevancy, vote-out supporters of an imposed solution, support defunding for competing geopolitical agencies and personally accept that this is our world, and it ain't perfect, nor will it ever be t'ain't the plan.
